<p>Extend the properties of exponents to rational exponents. N.RN.1 Explain how the definition of the meaning of rational exponents follows from extending the properties of integer exponents to those values, allowing for a notation for radicals in terms of rational exponents. <i>For example, we define $5^{\frac{1}{3}}$ to be the cube root of 5 because we want $(5^{\frac{1}{3}})^3 = 5^{(\frac{1}{3})^3}$ to hold, so $(5^{\frac{1}{3}})^3$ must equal 5.</i></p>	10.1

Interpret the structure of expressions.

Interpret parts of an expression, such as terms, factors, and coefficients. b. Interpret complicated expressions by viewing one or more of their parts as a single entity. <i>For example, interpret $P(1 + r)^n$ as the product of P and a factor not depending on P.</i> 	7.1, 10.2, 10.3

<p>A.SSE.2 Use the structure of an expression to identify ways to rewrite it. <i>For example, see $x^4 - y^4$ as $(x^2)^2 - (y^2)^2$, thus recognizing it as a difference of squares that can be factored as $(x^2 - y^2)(x^2 + y^2)$.</i></p>	8.1, 8.2, 8.3, 8.4
Write expressions in equivalent forms to solve problems.	
<p>A.SSE.3 Choose and produce an equivalent form of an expression to reveal and explain properties of the quantity represented by the expression. *</p> <ul style="list-style-type: none"> a. Factor a quadratic expression to reveal the zeros of the function it defines. b. Complete the square in a quadratic expression to reveal the maximum or minimum value of the function it defines. c. Use the properties of exponents to transform expressions for exponential functions. <i>For example, the expression 1.15^t can be rewritten as $(1.15^{\frac{1}{12}})^{12t} \approx 1.012^{12t}$ to reveal the approximate equivalent monthly interest rate of the annual rate is 15%.</i> 	8.4, 9.1, 9.2, 9.3, 9.5, 10.2

If f is a function and x is an element of its domain, then $f(x)$ denotes the output of f corresponding to the input x. <p>Interpret functions that arise in applications in terms of the context. Graph linear and quadratic functions and show intercepts, maxima, and minima. b. Graph square root, cube root, and piecewise-defined functions, including step functions and absolute value functions. e.
