<b>N-RN.2</b> Rewrite expressions involving radicals and rational exponents using the properties of exponents.	R.7
<b>N-RN.3</b> Explain why the sum or product of two rational numbers is rational; that the sum of a rational number and an irrational number is irrational; and that the product of a nonzero rational number and an irrational number is irrational.	R.7
<b>N-Q.1</b> Use units as a way to understand problems and to guide the solution of multi-step problems; choose and interpret units consistently in formulas; choose and interpret the scale and the origin in graphs and data displays.	R.3
<b>N-Q.2</b> Define appropriate quantities for the purpose of descriptive modeling.	R.3
